PROPOSED AMENDMENT TO NCAA BYLAW 11.1.2.1

RESPONSIBILITY OF THE HEAD COACH:

An institution's head coach is presumed to be responsible for the actions of all assistant coaches and other administrators who report, directly or indirectly to the head coach. An institution's head coach shall promote an atmosphere of compliance within his or her program and shall monitor the activities of all assistant coaches and other administrators involved with the program who report, directly or indirectly, to the coach.

PROPOSED LEGISLATION

AMENDMENT TO NCAA BYLAW 11.1.2.1

RATIONALE: A head coach should be presumed to have knowledge and, therefore, responsibility for the actions of those individuals associated with his or her team whom the coach directly or indirectly supervises. Rather than focusing on knowledge, or the presumption of knowledge, the bylaw is amended to presume only responsibility.

Effective Date – October 30, 2012

PROPOSED NCAA VIOLATION STRUCTURE

Level One – Severe breaches of conduct

- Seriously undermines or threatens integrity of NCAA enduring values

Level Two – Significant breaches of conduct

- Provides or intended to provide more than a minimal advantage

Level Three – Breaches of conduct

- Inadvertent/Isolated

Level Four – Incidental infractions

- Technical in nature
