Level III	MFB	Impermissible Telephone Communication (NCAA Bylaw 13.1.3.1)	A coach called a junior prospective student-athlete following the expiration of a window permitted by a telephone call blanket waiver (January 16-31) and prior to the next permissible date to call a junior prospective student-athlete under the blanket waiver (March 1).	The involved coach was prohibited from calling or exchanging electronic correspondence with any prospective student-athlete for 14 days. The football staff was prohibited from calling the involved prospective student-athlete for 30 days. The football staff received rules education regarding telephone calls.	2/9/2022
Level III	WGY	Impermissible Recruiter (NCAA Bylaw 13.1.2.1)	Two individuals who were not institutional staff members were present at an off-campus meal during a prospective student-athlete's official visit.	The gymnastics staff was prohibited from making or receiving telephone calls or sending electronic correspondence to any prospective student-athlete for seven days. The involved coach was prohibited from making or receiving phone calls or sending electronic correspondence for 14 days. The gymnastics staff was prohibited from recruiting off-campus for 14 days, and the involved staff member was also prohibited from engaging in any on- or off-campus recruiting activities for 14 days. The gymnastics staff received rules education regarding permissible recruiters.	4/30/22

Level III	WBB	Exceeding Student-Athlete Time Limits (NCAA Bylaw 17.1.7.2.1.6.1)	Student-athletes exceeded their weekly countable athletically related activities limit by thirty minutes during one week of summer activities.	The team reduced practice by one hour during one week of out-of-season workouts. The institution provided rules education to the women's basketball staff.	7/1/2022
Level III	WBB	Impermissible Non-Scholastic Evaluation (NCAA Bylaw 13.1.7.6.1)	A women's basketball assistant coach conducted an off-campus evaluation of prospective student-athletes enrolled at a non-scholastic institution outside of the July evaluation period.	The compliance staff provided rules education to the women's basketball staff. The impermissible evaluation was counted as one recruiting opportunity for the involved prospects and remaining recruiting opportunities for the involved prospects were reduced by one. The total recruiting person days in 2022-23 for women's basketball were reduced by two.	9/11/2022
Level III	MFB	Impermissible Benefits and Compensation (NCAA Bylaws 12.1.2.1.6 and 12.4.1)	A football student-athlete received compensation in exchange for signing memorabilia before such activities became permissible under new NCAA policy.	The student-athlete was withheld from competition for one game. The student-athlete repaid the amount that was impermissibly received.	9/29/2022
